# TERMS & CONDITIONS

1. The Organisation issues the application along with standard product by charging the price for the same overleaf- an application form can be submitted by any person having contractual capacity and who is resident and citizen of India. Submission of application means :-
2. (I) Applicant has accepted and agreed to abide by all organisation's rules, regulations, term, condition, referral program etc. Prevailing at the time of submission of application or any change, addition, alteration, modification etc. Made in the rules, regulation, terms, condition, referral program etc. by the organisation from the time to time after submission and acceptance of the application.  
(II) Applicant has fully understood the organisation's framed "Gramin Shiksha".  
(III) Applicant has not been forced or pressurized by any body to join the Gramin Shiksha.
3. After acceptance of the application by the organisation, applicant shall become the student of the organisation for purpose of referring the organisation's course in the framed "Gramin Shiksha".
4. The organisation has right to terminate the studentship when student's work found to be unethical and prejudicial to the interest of the organisation.
